J.S.S.A. - General Rules for all competitions unless otherwise stated.

- (1) All competitions and matches will be controlled by and under the auspices of the J.S.S.A.
- (2) All competitions will be competed for annually and trophies and shields will remain the property of the J.S.S.A unless the competition rules provide otherwise.
- (3) A code of conduct will be set by the Council which must be observed by all shooters.
- (4) All competitions are open to members of Clubs affiliated to the J.S.S.A.
- (5) Where not otherwise stated N.S.R.A. or I S.S.F. rules will apply.
- (6) Words denoting masculine are to be taken to include the feminine.
- (7) Officials of each Club will make themselves acquainted with the rules as a plea of ignorance will not be entertained.
- (8) All competitions and matches will be shot on ranges approved by the J.S.S.A.
- (9) All ranges must be so lighted as to light the entire range, levels as per N.S.R.A. rules.
- (10) All competitions shall be fired on J.S.S.A approved targets, including electronic targets approved by the J.S.S.A.
- (11) Unlimited sighters may be used in all competitions unless otherwise stated.
- (12) Telescopes will be permitted unless otherwise stated.
- (13) Any brand of ammunition authorised by the N.S.R.A. may be used and Clubs and competitors must supply their own ammunition.
- (14) The Council shall decide annually the entry fees, dates for competitions.
- (15) Junior competitions shall be open to persons qualifying as follows:Small-bore- under 20 years of age on 1st October preceding the competition.
 Air Rifle- under 20 years of age on 1st October preceding the competition.
- (16) In all team matches, unless otherwise specified, Clubs may provide only one coach for every two shooters on the range but in all individual competitions no coaching of any kind is allowed.

- (17) Unless otherwise provided for in the rules for any particular trophy or shield, ties will be decided by a shoot-off for first place.
- (18) Breach flags must be used at all times, other than when instructed by the range officer during the course of fire.
- (19) In Small-bore Rifle indoor competitions more than one shot on an aiming mark will incur one penalty point for each additional shot.
- (20) Unless the Council decides otherwise, Clubs shall send one representative to the inaugural and scoring meetings for any of the J.S.S.A. competitions.
 - Failure to do so will result in the entries not being accepted or the cards being disqualified unless there are extenuating circumstances.
 - Subject to the Council who will give at least 14 days' notice of all competition subcommittee meetings in its official organ, The Voisin Weekly.
 - Notification of scoring meetings will be given 7 days' notice in the official organ or on the targets.
- (21) A right of appeal will be allowed by any Club or member to the Appeals Committee in accordance with the Constitution of the J.S.S.A. provided that such Club or member notifies other parties involved of the intention to appeal and such appeal is made in writing to the Honorary Competition Secretary within 48 hours of the grievance.
 - Appeals must be accompanied by a deposit of £20 which will be refunded if the appeal is upheld.
- (22) Each home team must appoint Range Officer(s) who shall have full authority on the range for the duration of the competition.
- (23) An appeal will not be allowed on a target that has been re gauged.
- (24) The time limit for Small-bore Rifle indoor competitions will be 14 minutes per card which includes 2 minutes preparation time.

Sub Committees for Small-bore, Air Rifle and Pistol Disciplines

- (1) Each Committee will consist of a Chairman, a Competition Secretary and one member from each affiliated club that participates in that discipline.
- (2) The Committee will be responsible for the day to day running of the competitions in that discipline.
- (3) All competitions will be run in accordance with current J.S.S.A. rules.
- (4) Any dispute may be put to the Appeals Committee of the J.S.S.A.
- (5) All competition dates must be approved by the Council of the J.S.S.A.
- (6) All shooting teams or individuals representing the J.S.S.A. must be selected by the J.S.S.A.
 - Selection Committee or its nominated representatives e.g. Bisley etc.

AIR RIFLE CHAMPIONSHIP.

C.A Browne Shield (Perpetual) for the Air Rifle Island Champion.

Eastern Trophy (Perpetual) for the Junior Air Rifle Island Champion.

- 1. The competition will be shot in two stages at 10 metres under the spirit of the ISSF rules except where stated.
- 2. Entries will be classified according to the competitor's average as specified by their Club and based on their weekly scores with a minimum of five shoots.

 If no averages are submitted the shooter will be deemed Class A.

Stage 1: Initial Qualification

- (a) Qualification shoot of 60 shots to count.
- (b) JSSA approved paper targets may be used.
- (c) Integer scoring will be used.
- (d) The top eight go forward to stage 2. Countback will be used to settle all ties (top score in the 6th string, then if still a tie then the 5th string, and so on).
- (e) The competitor's name is to be written on each card and witnessed, signed and dated by a Club official.
- (f) The Junior Champion will be the junior competitor with the highest score in stage 1.
- (g) Class winners will be decided by the scores of stage 1. Countback will be used to settle all ties (top score in the 6th string, then if still a tie then the 5th string, and so on).

Stage 2: Shoulder to Shoulder Qualification and the Final

- (a) To be shot on a shoulder to shoulder basis on a neutral range, if possible, or on a range to be decided by the Honorary Competition Secretary or his representative.
- (b) Qualification shoot of 60 shots to count, followed by a standard final.
- (c) JSSA approved paper or electronic targets may be used.
- (d) Decimal scoring will be used.
- (e) The shoulder to shoulder qualification match will be used to determine the top three ranked competitors that will go forward to take part in the Kenitex Air Rifle Channel Island Championship, as this is the format in which that competition will be shot.
 - The winner of **the final** will automatically gain a place in the Kenitex Air Rifle Channel Island Championship, so if the eventual winner of the final was not in the top 3 of the shoulder to shoulder match, only the top two from that match would be offered places.

Where the qualifying shooters are unable or unwilling to shoot in the Kenitex Air Rifle Channel Island Championship their place will be offered to the shooter who had the next highest score in the shoulder to shoulder match.

(f) The Island Champion will be the competitor with the highest score at the end of **the final**. Ties will be decided in accordance with ISSF rules.

AIR RIFLE INTER PAROCHIAL.

G H Harris Trophy (Perpetual) for Air Rifle Inter Parochial Champions. J.S.S.A medals to members of the winning team.

- 1. Teams to be restricted to one from each Parish.
- 2. Teams to consist of four members.
- 3. Team members must be a permanent resident of that Parish for at least six months immediately prior to the date of the shoot. In the event of a shorter period of residence in the Parish he may shoot for that Parish in which he has resided for at least six months previously.

Students, whilst studying out of the Island, may shoot for their last Parish of residence in the

Island, subject to the above 6 month rule

- 4. (a) The Honorary Competition Secretary or his deputy will be in charge of the match.
 - (b) The match will consist of 40 shots at 10 metres standing, sighters to be fired prior to scoring shots, with a total time limit of 1hr. 15minutes.
 - (c) A tie to be decided on the night by a reshoot of the whole team, or at a time decided by the Competition Secretary.

AIR RIFLE CHANNEL ISLAND CHAMPIONSHIP.

KENITEX TROPHY for Air Rifle Channel Island Champion.

- 1. The competition will be shot under **the spirit of the ISSF rules** except where stated.
- **2.** To be shot at 10 metres range.
- 3. 'Air1' targets or approved equivalent to be used. The use of electronic targets is permitted.
- 4. Course of fire of 60 shots to count.
- 5. Timing and format according to a standard ISSF match.

- **6.** Scoring to be by inward gauging. Decimal scoring to be used.
- 7. Shots fired which miss the scoring rings will count and be marked as zero.
- **8.** The Channel Island Champion will be the competitor with the highest score at the end of the shoot. Ties will be decided in accordance with ISSF rules.

AIRGUN INDIVIDUAL AND PAIRS KNOCKOUT COMPETITIONS

1. The competition format

- a. Will be conducted on a knock out basis with each round being drawn at random.
- b. The draws for the competition will be made by the Air Rifle Sub Committee.

2. Course of fire and targets:

- a. The course of fire for each round is 20 shots, one shot in each element, using either five bull targets or single targets on card. Duration allowed to complete sighters and match shots is 45 Minutes.
- b. If single diagram targets are used, these must have pre-printed numbering which must be sequential across all 20 match targets.
- c. The targets may be supplied with an IKO sticker attached specifying a 'shoot by' date.
- d. The targets are not to be scored, gauged or tampered with in any way.
- e. The first and last targets are to be signed by each Competitor, have the handicap indicated on them, and one witness must also sign them.

3. Handicap:

- a. The competition will be run under 'own start' handicap conditions.
- b. The minimum handicap that can be nominated is 10 points and all handicaps must be an even number.
- c. A shooter may change their handicap for each round, but the new handicap MUST be pre-declared before the cards are shot and a witness sign off on the new handicap on the cards.

4. Scoring:

- a. A competitor's handicap will be added to the score of the cards. If the total is more than 200, two points will be deducted for every point over 200.
- b. In the case of an accidental two shots in one element there will be no penalty, just leave one target blank.
- c. All shots must show on the cards. Any zero scoring shots will incur a 1 point penalty after scoring and the handicap has been applied.
- d. At the scoring meetings each club will provide one scorer. No scorer– no score, unless otherwise directed by the committee.

5. Match Winner & Resolving Ties:

a. The winner of each match will be entitled to compete in the next round.

- b. In the event of a tied score, this will be decided by count back on the **last** string of 10 shots, **with half the handicap applied**. Failing a resolution of the tie then the next string of 10 will be used.
- c. If the second countback fails to yield a clear winner then the match is to be re-shot within two weeks of the original date.

6. Finals Night:

- a. The semi-final and final rounds (4 competitors remaining) will all be shot on one 'Finals Night' evening.
- b. The venue range will be decided by the competition secretary.
- c. Competitors will be drawn against each other and matches shot as above until the winner is determined.
- d. For the deciding the result of the final, count back will not be used. A shoot off will decide the winner consisting of 10 shots in 15 minutes, with half the handicap applied. This will be repeated until there is a winner.

7. Pairs Knock out

- a. The pairs will be drawn at random at the start of the competition.
- b. Apart from the above, the rules for the PKO are the same as the IKO. Score for the pair is the two shooter scores added.
- c. The pairs finals will be shot concurrently with the individual finals where required.

8. Misc:

a. Substitutes are not permitted to shoot an individual's cards

AIRGUN LEAGUE

1. Participation

- 1.1. Teams of 5 will shoot the league matches.
- 1.2. Teams consist of shooters who are a member of the club they are shooting for.
- 1.3. A shooter may only shoot once in each match for their team, i.e. no doubling up.
- 1.4. All clubs must be paid up members of the NSRA and JSSA.

2. Competitions / Awards

- 2.1. Team competition. The H. Briard Trophy (perpetual) is awarded for the team with the most points at the end of the league fixtures.
- 2.2. Individual competition. Inter Club 'B' Trophy is awarded to the shooter with the highest average score over the six matches. A minimum of four matches must be shot to qualify.

3. Fixtures

- 3.1. All match fixtures will be published at the start of the year.
- 3.2. All matches are to be shot at the venue, date and times specified.

4. Matches

- 4.1. The matches are to be shot on a shoulder to shoulder basis.
- 4.2. The host club will, prior to the match, confirm the number of details that will be
- 4.3. Each detail is to have at least 1 shooter from each club participate.
- 4.4. Matches are of a 40 shot duration, with unlimited sighters during a set 'preparation and sighting' period at the start.

- 4.5. Matches will be shot in the spirit of ISSF rules.
- 4.6. Match composition:
 - a) Once the range is clear, each detail shall have a 5 minutes setting up period, followed by;
 - b) a 10 minute preparation and sighting time, followed by;
 - c) a 40 shot match of:
 - i. 60 minutes duration on paper

targets, or

ii. 50 minutes duration on electronic targets.

4.7. Announcements:

- a) Shooters will be called to the line at the start of the setting up period: "Shooters to the line."
- b) Preparation and Sighting time will be commenced by "Preparation and sighting time, START!". A warning will be given at "30 Seconds.", followed by "Preparation and sighting time, STOP!" and then "Change to match targets.".
- c) After checking shooters have changed to match targets, "You have XX minutes in which to shoot 40 match shots.", then "Match firing, START!". Warnings will be given at "10 minutes." and again at "5 minutes.", and then "STOP!".
- 4.8. Matches are to be run to the schedule arranged. If a whole squad finishes early and all the shooters of the next squad are willing to start early, the next squad may commence earlier than timetabled.
- 4.9. A range officer, provided by the hosting club, will preside over the match at all times.

5. Timing

- 5.1. Matches hosted at St Lawrence Miniature Rifle Club and Eastern Air Rifle Club will commence at the below times on Monday nights, on the dates agreed at the beginning of the shooting season:
 - Call to the Line 7.30pm
 - Preparation and Sighting 7.35pm start, 7.45pm stop
 - Match Start 7.45pm
- 5.2. Matches hosted by St John Shooting Club will commence at the below times on Sunday mornings, on the dates agreed at the beginning of the shooting season:
 - Call to the Line 9.30am
 - Preparation and Sighting 9.35am start, 9.45am stop
 - Match Start 9.45am
- 5.3. The next details will be 'called to the line' once the last shooter is finished, or the maximum time is reached, and the range has been cleared. The start of the next detail should follow as soon as the range is clear but is at the desecration of the range officer, however the following detail(s) should follow the prescribed match format and timing.

6. Scoring

- 6.1. Each club will declare their 5 shooters prior to the match commencing.
- 6.2. Each club will list its shooters from 1 to 5, with 1 being the shooter currently achieving the highest scores (based on their club average) and 2 being the next highest, and so on. Clubs will not deliberately manipulate the order of their

shooters as to deliberately effect the match results.

- i. Shooter 1 from each club will compete against each another on a straight 40 shot integer score basis
- ii. The winner will be awarded 2 points for their team, second place 1 point and third 0 points
- iii. Any tied scores will be subject to countback (the best score in the final 10 shots, and so on)
- iv. The same is repeated for shooters 2-5
- 6.3. Shooters can participate in any of the arranged details, they do not need to be arranged so that specific shooters are shooting concurrently.
- 6.4. Any team not fielding a shooter for a match will not be eligible to score team points, i.e. where perhaps multiple clubs are missing shooters the missing shooters cannot tie with a zero score and earn points for their team.
- 6.5. The total team score will be calculated by adding up the team points achieved in each of the 5 individual shooter's matches. The team with the highest team points wins the match.
- 6.6. Match results score the following league points:
 - a) In the case of two way matches: 2 points for a win, 0 points for lose.
 - b) In the case of three-way matches: 2 points for a win, 1 point for second, 0 points for last.
 - c) In the case of a tie between 2 or more teams, the points are divided equally between the tying teams. E.g. Two-way match draw each team gets 1 point. Three way match draw for second place each team gets 0.5 point. Three way match all teams tie each team gets 1 point. ((2 + 1) / 3)

7. Administration

- 7.1. League Organisers: The air rifle competition sub-committee
- 7.2. League Coordinator: The air rifle competition secretary.
- 7.3. In the case of any disputes and/or protests, these should be forwarded in writing to the chairman of the air rifle competition sub-committee within 1 week of the incident in question, where a judgement will be made.

AIR RIFLE INDIVIDUAL LEAGUE

Below are rules as outlined for the Air Rifle Individual League.

Competition / Award:

The winner of the Air Rifle Individual league will be awarded the Wayne Lewis Memorial Trophy.

Participation:

Membership : Individuals must be a member of a JSSA affiliated club

Fixtures:

Event(s) : Air Rifle Individual League will consist of 6 matches

Dates : 1 match per month starting in October and finishing in

March, or as scheduled by the Air Rifle Competition Sub-

Committee

Match Time : 60 Shot – 1 hour 15 minutes (per ISSF rules)

Final – per ISSF rules

Venue : Any club capable of running ISSF matches and finals on

an electronic target system

Rules : All matches to be shot in the spirit of ISSF rules

All scoring will be on a decimal basis

Scoring:

Match points will be awarded to competitors based on their finishing positions in both the 60th shot match and the final. These are combined to calculate a competitors total match points.

Best 4 of 6 : A competitors best 4 total match points will be taken and

totalled. So the maximum achievable is 120 pts.

Entries

If more than 8 competitors would like to participate in a match a second detail will be organised and the final moved back to accommodate this.

Candidates for each detail will be drawn at random and their respective match start times will be confirmed prior to the match taking place.

Only the top 8 from the 60shot matches will be awarded points, and only they will qualify to participate in The Final.

Ties

If competitors are tied on final total match points then the best 4 scores achieved in the 60shot matches for each shooter will be totalled and the one with the highest total score will be awarded the higher ranking.

Classes

There are no classes for these matches. The competition will be mixed, with men, women and juniors competing in the same competition.

Selections

It is anticipated that the JSSA Selection Committee will look to the results of these matches to inform their selection of candidates, such as selecting shooters for the Island Games, CSF(ED) etc. So those looking to be selected to represent Jersey are encouraged to enter this competition.

Rescheduling Matches

If for whatever reason matches need to be changed the JSSA Competition Air Rifle Sub-Committee Chairman and Secretary must be informed at least 14 days prior to the competition date. They will then approve the change and ensure it is communicated to all those involved, as appropriate. The decision of the JSSA Competition Air Rifle Sub-Committee Chairman and Secretary on any changes will be final. Rescheduled match details will be communicated to competitors at least 14 days prior to the date of the new match.

PISTOL CHAMPIONSHIPS.

The J.S.S.A. Shield (perpetual) for the .22 Standard Pistol Outdoor Champion and the GOTEL Trophy (perpetual) for the Air Pistol Island Championship are currently on long term loan to the JPA. (Council meeting 271106).

SMALL-BORE RIFLE LEAGUE.

HUELIN SHIELD (perpetual) for Division 1 Champions. ALBATROSS TROPHY (perpetual) for Division 2 Champions.

MARTIN TROPHY (perpetual) for Division 3 Champions. Revised Annually.

HARRIS TROPHY (perpetual) for Junior Champions.

J.S.S.A. medals will be awarded to all members of winning teams who have shot in 50 per cent of the matches.

NORTHY TROPHY (perpetual) and J.S.S.A. medal for the individual with the highest League average in senior matches for the season, being the average of all shoots with a minimum of all but two available matches.

LE CAPPELAIN SHIELD (perpetual) and J.S.S.A. medal for the individual junior shooter with the highest League average in JSSA Junior League matches for the season, being the average of all shoots with a minimum of ten shoots.

J.J.LE MARINEL TROPHY for the winners of the Junior League Champions versus the Rest

- 1. Only those who have competed in that years Junior League may shoot in the competition. The Honorary Competition Secretary shall decide the date for the match on consultation with the Junior League Champions.
- 2. If the Junior League Champions win the Trophy for four consecutive years they shall win it outright—and the Trophy shall become a perpetual Trophy for that Clubs Junior shooters. The rules for the Trophy shall be decided by the Club.
- 3. Shooting conditions shall be those that apply to the League.

H BRIARD TROPHY (perpetual) for the winners of the Air Gun League [Council meeting 8.9.2003]

LEAGUE RULES.

- 1. The League and all matches will be controlled by and under the auspices of the J.S.S.A.
- 2. Team entries must be received by the Honorary Competition Secretary not later than the first Sub Committee Meeting after the A.G.M.
- 3. The Council shall make all arrangements for all League matches, including the composition of each Division, at least fourteen days prior to the commencement of shooting, and all dates and places for such shall be notified to each affiliated Club. All matches in both the Junior and Senior JSSA Leagues shall be shot even if one Club is unable to field a full team or any team at all.
- 4. Once a member has fired for any Club he will not be allowed to shoot for any other Club during the current season without the permission of the Council.
- 5. All League matches will be fired in the prone position at 15 yards range.

6. TEAM COMPOSITION.

- (a) Clubs shall enter teams of six members for Senior matches and four members for Junior matches. Juniors must be under 20 years on 1st October.
- (b) Where a Club enters more than one team the best available six must be placed in the 'A' team, the next best six in the 'B' team and so on.

A two point difference between members of adjacent teams will be allowable.

Members of all teams must be registered. All averages as in rule 7.

7 TEAM REGISTRATION

All teams must be submitted to the Honorary Competition Secretary at least SEVEN days before the first League match of the season and the average of each member, to one decimal point, must be declared.

This average must be calculated from the best FIVE of the last SIX League shoots.

Any deficiency in the number of shoots must be made up by the last two card practice shoots up to the time of entry.

Clubs failing to register teams in the prescribed manner will forfeit all matches until such time as registration has been undertaken at least seven days prior to any league match.

8. TEAM CHANGES.

After the initial registration a Club may, at any time, change the composition of a team as follows:-

- (a) By introducing a new member who must be placed in an appropriate team on his average as calculated in 7 above.
- (b) A shooter who has never shot in a League match as a senior or as a Junior may be placed without notice in the lowest team of a Club provided that the Club is satisfied that this is appropriate.
- (c) Clubs to submit applications to the Competition Secretary in respect of respective shooters returning to the league.
- (d) By promoting / relegating team members.
 - This may only take place if a difference of one or more points exists between the averages of the shooters.
- (e) If the introduction of new shooter/s results in seven or more available shooters then the lowest member/s on average are automatically relegated to leave only six registered shooters

Transfers made under (a), (c) and (d) must be sanctioned by Promotions and Relegations by application before 10.30 am on the Saturday prior to the match.

The Promotions and Relegations committee, in addition to dealing with applications from Clubs, will make compulsory promotions and relegations where circumstances demand.

No change may be ordered unless there is a two point or greater difference between the averages of the shooters.

Provided always that the Promotions and Relegations committee may under extenuating circumstances vary the registration of a shooter.

During a season a shooter will not be deemed to have an average until he has shot in three matches. Until that time the shooter's average will be that at initial registration, which shall be used for promotion and relegation purposes until that shooter has fired in three matches.

- (f) NOT AVAILABLE; shooters missing three consecutive matches shall be automatically classified as 'not available' and must be re-registered on a basis consistent with this rule 8 prior to shooting in a subsequent match but any such re-registration shall be void if the shooter does not shoot the next following match. In this event the shooter with the highest league average in the next lower team shall automatically be promoted.
- 9. The shooter may nominate, ahead of shooting, which team they are shooting for first, failing which they shall be deemed to have shot for their registered team.
 - This rule shall not apply to Junior League members who, where shooting in a senior match in the same evening as a junior match, may fire concurrently.
 - If, however, they are shooting in two senior matches on the same evening the first two cards shall count in the junior match.

The number of times per season on which a shooter may shoot as Reserve for a higher team without also shooting for a lower team in the same week shall be unlimited.

The number of times per season on which a shooter may shoot as Reserve for a higher team and also shoot for a lower team in the same week, shall be limited to two and on the third and any subsequent occasion that score shall be discounted.

- 10. Each senior team shall fire at the appointed range on the night of the shoot and as a minimum one member from each team shall shoot together on the final detail of that match.
- 11. No shooting in the League shall take place before 7.30 pm on the day of the match, unless prior agreement is reached between both Team captains, sufficient notification must also be given before changes are made.

No shooting shall be allowed before 6.00 pm.

No Club shall be under any obligation to agree to shoot any earlier than 7.30pm. Any cards shot early should not be marked at the time and should be left to be marked together with the cards during the regular match time. Any cards that are marked early shall be disqualified. This rule shall apply equally to both senior and junior matches.

- 12. Coaches will be permitted subject to there being enough space on the range, and will be at the discretion of the Range Officer.
- 13. In every League match each team member will fire 20 rounds deliberate on two consecutive match cards; 10 rounds on each card.

There will be a preparation time of two minutes and a shooting time of twelve minutes per card; including sighters. Dry firing is permitted during the two minutes preparation time.

Any shooter who live fires during the preparation period will be automatically disqualified from that match/competition.

The appointed Range Officer will warn competitors 10 minutes after the order to commence has been given that there are two minutes remaining by calling "Two minutes".

He shall declare a cease-fire at the expiration of twelve minutes after the order to commence has been given, or sooner if satisfied that all shooting has ended.

He may, however, extend the time limit at his discretion in the event of mechanical failures or other valid causes.

Sighters will be put on the right hand side of the card.

14. The scoring of cards will be carried out where possible by members of opposing Clubs who, where possible, should not be present on the firing point during the firing of the cards they score. When there is a disagreement between the scorers then a third person will be called to referee who will give his decision.

All gauged shots will be marked as such.

Scoring will be in accordance with rule 2, subsection 5 of the N.S.R.A. Rule Book.

A team member intentionally firing on the wrong card will be disqualified and will be reported to the Council of the Association for disciplinary action.

- 15. It will be the duty of the home Club to forward all score sheets and any other notes which may be considered necessary, not later than 10.30 am on the Saturday after the match, to the Honorary Competition Secretary or other person nominated by the Council.
- 16. In all League matches two points shall be awarded for a win and one point for a draw. The teams in each Division with the highest number of match points upon completion of all League matches for the season shall be the winners.

Ties for first place in any Division shall be shot off on a neutral range as decided by the Honorary Competition Secretary.

The conditions applicable to the lowest division in the League may be amended before the season starts by the Small-bore Sub-Committee in any matter it sees fit (subject always to the direction of Council). Any such changes shall be clearly published in the Voisin Weekly.

- 17. In the event of a Club's range not being available on a fixed evening, it will be permissible for the two competing teams to shoot the matches on any other day than a Thursday by mutual agreement provided that the Honorary Competition Secretary is notified previously.
- 18. In all League matches the recognised N.S.R.A. match cards will be used.

All competitions shall be fired on J.S.S.A approved targets, including electronic targets approved by the J.S.S.A.

Each Club will supply its own ammunition.

Any brand may be used as authorised by the N.S.R.A.

- 19. The home Club shall have full control and be responsible for the proper conduct of the match. They, through their proper officials, shall decide all questions which may arise relative to such match when called upon to do so.
- 20. Where not otherwise provided for in these rules the N.S.R.A. Rules and Regulations in force at the time will govern shooting in all League matches.
- 21. Matches postponed by mutual agreement must be refired in the half season in which they were postponed, and must be re-shot before the date of the last league match in that half of the season.
- 22. It is the duty of Clubs to comply with all League rules.

Any Club aggrieved by the failure of any Club to do so may appeal to the Competition Secretary. The Appeals Committee will then assess all relevant facts but will not prejudice a Club if it has acted in good faith.

SMALL-BORE INDOOR ISLAND CHAMPIONSHIP.

RANK Trophy (perpetual) and J.S.S.A. medal for Small-bore Rifle Indoor Island Champion.

GERALD MICHEL JUNIOR Trophy (perpetual) and J.S.S.A. medal for Junior Small-bore Rifle Indoor Island Champion.

PLATT MEMORIAL Trophy (perpetual) and J.S.S.A. medal for top scorer at 15 yards in stage 1.

PALLOT MEMORIAL Trophy (perpetual) and J.S.S.A. medal for top scorer at 25 yards in stage 1.

POINGDESTRE FAMILY Trophy (perpetual) and J.S.S.A. medal for top family pair in stage 1.

VETERANS TROPHY (perpetual) and J.S.S.A. medal for the winner. Entrants must be 60 years of age or over on the 1st October.

- 1. Competition to be shot in two stages at 15 yards and 25 yards indoors.
- 2. Entries will be classified according to the competitor's average which will be based on their League average or on their last five Club shoots.

If no average is submitted the shooter will be deemed Class A.

- 3. Stage 1.
- (a) 20 shots (two cards) at 15 yards and 20 shots (two cards) at 25 yards.
- (b) The top eight and equal eighth to go forward to stage 2.
- (c) The Junior Champion will be the junior competitor with the highest score in stage 1. Entries for the junior competition must be clearly indicated at the time of entry to the Island Championship.

Ties to be fired under the same conditions but on a neutral range where possible, however if two or more juniors make the senior final this will be deemed the tie shoot.

- (d) Ties for the Platt Memorial Trophy to be shot on a shoulder to shoulder basis until the winner is decided.
- (e) Ties for the Pallot Memorial Trophy to be shot on a shoulder to shoulder basis until the winner is decided.
- (f) The Family Trophy is open to pairs consisting of a husband and wife, parent and child or grandchild, or brothers and/or sisters.

In the event of a tie one card will be shot at 15 yards and one card at 25 yards until the winners are decided.

4. Stage 2.

(a) To be shot on a range to be determined by the Honorary Competition Secretary, shoulder to shoulder, 20 shots at 15 yards and 20 shots at 25 yards.

- (b) The Rank Trophy will be awarded to the competitor with the highest aggregate at stage 2. Tie shoots to be decided by a re-shoot of 20 shots at each distance and, if still a tie, by 10 shots at each distance until the winner is decided.
- (b) The Rank Trophy will be awarded to the competitor with the highest aggregate at stage 2 [Council meeting 23.3.2005]
- 5. The top four shooters from stage 2 will take part in the Channel Island Championship.

SMALL-BORE RIFLE THREE POSITIONAL ISLAND CHAMPIONSHIP.

C.R. STEEL Trophy (perpetual) for the Small-bore Three Positional Island Champion.

- 1. To be shot on a range that can accommodate sufficient targets at 1.5 metres high for the standing position. Stages 1 and 2 to be shot on two consecutive weeks at 15 yards range.
- 2. Stage 1.
- (a) 20 shots in each of the kneeling, prone and standing positions in 2 hours 38 minutes.
- (b) The top eight and equal eighth go forward to stage 2.
- (c) Stage 2 will only be fired if there are more than eight competitors.
- 3. Stage 2.
- (a) 20 shots in each of the kneeling, prone and standing positions in 2 hours 38 minutes.
- (b) The Champion will be the competitor with the highest aggregate in stages 1 and 2. Ties will be decided in accordance with UIT rules.

SMALL-BORE RIFLE OUTDOOR ISLAND CHAMPIONSHIP

- 1. To be shot under N.S.R.A. Rules.
- 2. Entries must be received by the Outdoor Competition secretary at least one week prior to the competition.
- 3. A draw/ballot will take place prior to the competition to allocate firing points. If more than 14 entries are received, a draw will also take place to allocate details with classes being split into equal numbers per detail.
- 4. This will be shot in classes A,B, and C, Veterans and Juniors. All class, Veterans and Junior Medals will be awarded for the First Stage and only if there are more than 3 competitors in a class.

5. Stage One:

60 shots at 50 metres outdoors with decimal scoring. The top 8 and equal scores to go forward into stage 2. When more than one detail, the top 4 from each detail will go forward.

The Junior champion will be the junior with the highest score in stage 1

Tie shoots will be decided by a shoot consisting of 10 shots in 15mins. If still undecided, a two shot series shot off will commence.

6. Stage Two:

60 shots at 50 metres outdoor with decimal scoring.

The champion will be the competitor with the highest score attained in stage 2 only.

Tie shoots will be decided by a shoot consisting of 10 shots in 15mins. If still undecided, a two shot series shot off will commence.

The competition will **commence** at 10.00a.m. Entry and Range fees will be decided by the J.S.S.A.

SMALL-BORE RIFLE CHANNEL ISLANDS CHAMPIONSHIP.

- 1. To be shot in two stages.
- 2. Stage 1 to be organised by each Island separately.

 Jersey's stage 1 to be concurrent with the Island Championship
- 3. The top four scores to go through to the final. Ties for fourth place to be shot off.
- 4. Final stage to be shot on a shoulder to shoulder basis at the same weekend as the Inter Insular.
 - Times to be arranged by the host Island bearing in mind the visitors travel arrangements.
- 5. Both stages to be shot at 15 and 25 yards; 20 shots at each distance. Unlimited sighters with 14 minutes (including two minutes preparation time) for 10 shots plus sighters.
- 6. The final to be four consecutive details.
- 7. The winner of the final to receive the trophy.

 In the event of a tie there will be a shoot off of 10 shots at 15 yards and 10 shots at 25 yards. The trophy can be won by the same person any number of times.
- 8. In exceptional circumstances the host Island, with prior agreement, may opt to shoot the final as 40 shots at either 15 or 25 yards according to range availability.
- 9. The host Island to purchase a medal and pay for the cup to be engraved.
- 10. All other conditions to be N.S.R.A.

SMALL-BORE RIFLE. PRESTCOLD COMPETITION.

PRESTCOLD Trophy (perpetual) for the Small-bore Rifle Handicap Team Champions. J.S.S.A. medals for members of the winning team.

- 1. Clubs may enter as many teams as desired but each team shall consist of four members.
- 2. The draw for the competition will be made by the Council or its appointed subcommittee.
- 3. Teams members will fire in the prone position at 15 yards on N.S.R.A. targets; ten shots to count.
- 4. The competition will be run under 'own start' handicap conditions. Handicaps to be within five points of current League or Club average subject to a minimum of five points.
- 5. The Secretaries of Clubs, when making entries for this competition must submit a list of each team giving the names of the members who will shoot in each team and the handicap chosen by each member.
- 6. Every team member must have a handicap and this handicap shall be maintained throughout the competition unless such member notifies the Secretary of the appropriate Committee of any change at the time of marking of that round, so that any such change shall be effective for the following round.

Club representatives are responsible for ensuring the accuracy of the cards before they are sent out.

7. In the event of a member of a nominated team being unable to compete a reserve may take his place, such reserve must neither be a member of, nor have fired in, any other team in this competition and must accept the handicap of the team member he replaces.

8. The name of the competitor and his handicap will be entered on each target before it is despatched by the J.S.S.A.

Alteration by the witness of name only and not of handicap on the target will be permitted.

9. The targets will not be gauged, scored or tampered with in any way.

The targets will be signed by each team member and one witness before despatch to the Prestcold Honorary Secretary to reach him not later than 7.30 pm on the date stamped on the targets, targets not received within the specified times will be disqualified.

- 10 Teams will be drawn in pairs. The winning team will go through to the next round. In the event of a tie graduated gauges will be used to break the tie.
- 11. Handicaps will be added to the score of the card provided that if the total is more than 100, two points will be deducted for every point over 100, any penalty points will be deducted from the score after the handicap has been applied.
- 12. At the scoring committee meetings each Club will provide one scorer. No scorer-no score, unless otherwise directed by the Committee.
- 13. The final & semi-finals of the competition will be fired as a shoulder to shoulder match, two from each team, unless mutually agreed otherwise on a neutral range, until the winner is determined.
- 14. Graduated gauges will not be used when marking the cards for the final two competing teams in the Final

- 1. The draw for the competition will be made by the Council or its appointed sub-committee.
- 2. Competitors will fire in the prone position at 15 yards on N.S.R.A. targets; ten shots to count
- 3. The competition will be run under 'own start' handicap conditions. Handicaps to be within five points of current League or Club average subject to a minimum of five points.
- 4. Every competitor must have a handicap.

This handicap shall be maintained throughout the competition unless such member notifies the Secretary of the appropriate Committee of any change at the time of marking of that round, so that any such change shall be effective for the following round.

Club representatives are responsible for ensuring the accuracy of the cards before they are sent out.

5. The name of the competitor and his handicap will be entered on each target before it is despatched by the J.S.S.A.

No subsequent alteration will be permitted without prior authority of the Secretary of the Committee.

6. The targets will not be gauged, scored or tampered with in any way.

The targets will be signed by each competitor and one witness before despatch to the Secretary of the Committee to reach him not later than 7.30 pm on the date stamped on the targets.

Targets not received within the specified times will be disqualified.

7. The competition will be conducted on a knock out basis and the competitors will be drawn in pairs.

The winner of each round will be entitled to compete in the next round. In the event of a tie this will be broken by the use of graduated gauges.

8. When eight competitors remain the final rounds will be shot on one evening.

Competitors will be drawn in pairs as in 7 above until the winner is determined.

The range will be decided by the Competition Secretary.

- 9. Handicaps will be added to the score of the card provided that if the total is more than 100, two points will be deducted for every point over 100, any penalty points will be deducted from the score after the handicap has been applied
- 10. At the scoring committee meetings each Club will provide one scorer. No scorer-no score, unless otherwise directed by the Committee.
- 11. No substitutes are permitted to shoot an individual's card.
- 12. Graduated gauges will not be used when marking the cards for the last two competitors in the Final.

Two persons with unlimited average.
Two persons with average under 194.
Two persons with average under 191. Two persons with average
under 188.

Where a junior has fired for both their Club's senior and junior teams and therefore has both a senior J.S.S.A. average and a junior J.S.S.A. average, the average for which ever team has the highest number of matches shot should be used for the purposes of selecting teams for this competition. BULLSEYE G E M TROPHY (perpetual) and J.S.S.A. medals for members of the winning team.

- 1. No person may shoot for more than one Club but may shoot for any Club of which he is a paid up member.
- 2. Teams of eight shall be selected on the last published averages prior to the shoot.

Where a junior has fired for both their club's senior and junior teams and therefore has both a senior J.S.S.A average and a junior J.S.S.A. average, the average for

whichever team has the highest number of matches shot should be used for the purposes of selecting teams for this competition. For the avoidance of doubt, three shoots are required to constitute having an average.

The combined individual averages of the team must not exceed 1520. Whilst not mandatory, Clubs are encouraged to include at least two junior shooters.

3. The Competition will be shot at 25 yards range.

Each team member shall fire 20 shots to count (two cards) in a time limit of 14 minutes per card (including two minutes preparation time).
Unlimited sighters will be allowed.

4. The Trophy will be awarded to the team with the highest score. In the event of a tie the trophy will be shared.

SMALL-BORE RIFLE. GUERNSEY TROPHY.

GUERNSEY TROPHY (perpetual) for the winning team of the Small-bore Rifle Three Cornered Match.

- 1. The competition is open to teams of eight from the Bailiwick of Guernsey, the Bailiwick of Jersey and the County of Hampshire.
- 2. The competition will be held in succession in Hampshire, Jersey and Guernsey.
- 3. The County or Island in which the match is fired in any year shall provide the range and make all firing arrangements.
- 4. When the match is fired in either of the Islands it will be permissible, if practicable, to fire it concurrently with the Small-bore Inter Insular match.
- 5. The competition will always be fired at 15, 20 or 25 yards range.
- 6. The conditions generally shall be the same as those ruling in the Inter Insular competition.
- 7. Failing any special conditions applicable to the match, N.S.R.A. regulations shall apply.
- 8. The J.S.S.A. shall be the governing body.
- 9. Any alteration to the rules may be initiated by the J.S.S.A. or by either Guernsey or Hampshire. Any suggested alteration to the rules must be submitted in writing to the Honorary Secretary of the J.S.S.A. The decision of the J.S.S.A. shall be final.

SMALL-BORE RIFLE. THE WHYTE & MACKAY TROPHY.

THE WHYTE & MACKAY TROPHY for the Jersey Individual Outdoor Championship.

The winner to have the title of the Jersey Long Range Bisley Small-bore Rifle Champion of the year.

Eligibility: - N.S.R.A. RULE Section 2, Sub section3.

CONDITIONS.

- 1. To be fired concurrent with the Earl Roberts British Championship.
- 2. All Jersey competitors in the first stage will be placed in one squad. Single entry.
- 3. The trophy will be awarded to the Jersey competitor who makes the best score in the furthest stage.

A tie will be decided by the best 100 yards score in the furthest stage; if still a tie, by the use of graduated gauges on the 100 yard card(s) in the furthest stage.

4. Course to follow the British Championship stages.

If decided in the first or second stages, the result will be based on 40 shots, 20 at 50 metres and 20 at 100 yards.

Otherwise the result will be based on the final stage of the British Championship (ex 800).

5. Emblematic badges will be awarded to the leading three competitors.

SMALL-BORE AND AIR RIFLE INTER INSULAR.

GRASSETT NEAME and LE RICHE TROPHIES for the Inter Insular.

General Rules.

- 1. The competition shall be competed for annually alternatively in each Island for the Grassett Neame and Le Riche Trophies.
- 2. Two teams shall be drawn from bona fide members of Clubs affiliated to either the Guernsey Air Rifle Association or the Jersey Small-bore Shooting Association and resident in either Island for six months immediately prior to the shoot or are natives of the Island.
- 3. Teams will consist of eight competitors at Air rifle and eight competitors at Small-bore rifle shooting. The whole match will be completed on the same day.
- 4. The ranges will be determined by the Home Association.
- 5. All details (both disciplines) will be squadded.
- 6. The scoring of both Air rifle and Small-bore rifle will be carried out by one scorer from each Island and a referee from the host Island. Their decision will be final.
- 7. The Air rifle and Small-bore totals will be added together and the Island with the highest total will hold the trophy for one year.
 - In the case of a tie the match shall be declared a draw.
- 8. In the case of any dispute not determined by the rules each team shall nominate an individual who shall be empowered to settle matters.
- The host Island will provide a Chairman who shall have a casting vote only in the case of a tie.
- 9. The match shall be fired on the last Saturday in March, if possible, subject to a weeks difference either way to avoid Easter.

10. The Grassett Neame shall remain the property of the Guernsey Air Rifle Association and the Le Riche Trophy shall remain the property of the Jersey Small-bore Shooting Association.

The holders of the trophies shall be responsible for their safe keeping and engraving. The insurance of the trophies shall be the responsibility of the owners.

THE IAN FOSTER JUNIOR CHAMPION TROPHY.

- (1) Open to any junior of any club or youth organisation under the age of 20 years on the 1st October preceding the competition.
- (2) A junior may only enter the competition through one club or youth organisation.

 Non-affiliated members must sign the visitor's book of the club that they are shooting at.
- (3) The competition will consist of two stages.
- (4) First stage.

Each entrant shall shoot seven 15 yard cards (70 shots) between the 1st October and the last day of February.

The best five of the seven cards shall be counted to obtain a score ex 500.

The two juniors with the highest score from each Club will be eligible to compete in the second stage of the competition.

In the event that any club or youth organisation has either one or two junior entrants, that junior or juniors as the case may be, shall be eligible to enter the second stage of the competition.

- (5) Each club or youth organisation will be responsible for organising the first stage and submitting the names of the qualifying juniors to the J.S.S.A. competition secretary after the last day of February.
- (6) Second stage.

The qualifying juniors will shoot two 50 metre cards (40 shots to count) shoulder to shoulder on a date arranged by the Jersey Outdoor Small-bore Rifle Club.

The conditions of the second stage shoot shall be in accordance with the rules of the N.S.R.A.

The winner of the trophy will be the junior with the highest score ex 400.

CONSTITUTION OF THE JERSEY SMALLBORE SHOOTING ASSOCIATION

1. NAME.

The Association shall be called the JERSEY SMALLBORE SHOOTING ASSOCIATION.

2. OBJECTS.

The objects for which the Association is established are:-

(7) The trophy will remain perpetual.

- (a) To foster and support all small-bore rifle, pistol and air weapon shooting in the Island.
- (b) To determine rules and conditions which shall prevail at all competitive and individual shoots between members of clubs affiliated to the Association
- (c) To do all other such lawful things as may be conducive directly or indirectly to any of the above objects.

3. MEMBERSHIP.

Membership of the Association shall be open to all small-bore rifle, pistol and air weapon clubs established in the Island.

The subscription payable by each affiliated club shall be determined at each Annual General Meeting of the Association and shall be due on the first day of October in each year and shall be payable in advance.

All clubs affiliated to the Jersey Small-bore Shooting Association must also affiliate to the National Small-bore Rifle association.

4. OFFICERS.

The Office Bearers of the Association shall be:

- (a) A President.
- (b) Five Vice Presidents.

- (c) An Honorary Treasurer.
- (d) An Honorary Secretary.
- (e) An Honorary Competition Secretary for each of air rifle, pistol and small-bore.(f) An Honorary Assistant Secretary who will form an Executive and (g) An Honorary Auditor or Auditors.
- (h) Such other Office Bearers should the necessity arise.

The Association, at any General Meeting, may also appoint any other Honorary Officers or Members as it deems expedient.

5. ROLE OF PRESIDENT.

The President, or failing him one of the Vice Presidents, shall preside at the Annual General Meeting,

Special General Meetings, Council Meetings and at any social functions arranged by or for the Association. In the absence of the President and all the Vice Presidents at any meeting a Chairman shall be elected, from among those present, to act at that meeting.

ROLE OF HONORARY SECRETARY.

The Honorary Secretary shall keep minutes of the business transacted at all General and Council meetings, shall record those present at the meetings and shall perform such other duties relating to the office of Secretary as may be required from time to time.

ROLE OF HONORARY TREASURER.

The Honorary Treasurer shall receive payments of monies due to the Association and shall make payments on its behalf.

He shall keep proper accounts of all such monies received and paid during the business year and shall furnish a Financial Statement, duly audited, at the Annual General Meeting and shall at such other times as may be required by the association or it's Council.

ROLE OF AUDITOR(S).

The Auditor(s) shall examine the books of account at least once annually and shall report there on in writing in the form of a certificate appended to the Financial Statement.

6. ANNUAL GENERAL MEETINGS AND SPECIAL GENERAL MEETINGS.

The Annual General Meeting of the Association shall be held during the first two weeks of September of each year for the purpose of electing Office Bearers for the ensuing year, considering the Annual Report and the Financial Statement and transacting any other business.

A Special General Meeting of the Association shall be convened by the Secretary on the authority of the President, or on the written request of at least eight members of the Council.

Seventeen members shall form a quorum at any General Meeting.

Seven clear days' notice, with agenda shall be given by the Honorary Secretary of any General Meeting.

At any General Meeting of the Association all affiliated Club members may attend but will not have the right to make or second propositions and will not have the right to vote.

The Vice Presidents, Honorary Treasurer, Honorary Secretary, Honorary Competition Secretaries and

Honorary Assistant Secretary (but not Committee and Sub Committee Honorary Secretaries), Honorary Officers and members appointed under Rule 4 and three delegates appointed by each affiliated club shall have a voice and a vote at all General Meetings of the Association provided that all delegates must be fully paid up members of their respective clubs.

The President or his deputy shall have a casting vote only.

Any member may call for a vote by ballot, in which case voting shall be by ballot, otherwise it shall be by show of hands.

7. CONDUCT OF COUNCIL MEETINGS.

The management of the affairs of the Association shall be vested in a Council consisting of:(a) The President.

- (b) The five Vice Presidents.
- (c) The Honorary Treasurer.
- (d) The Honorary Secretary.
- (e) The three Honorary Competition Secretaries.
- (f) The Honorary Assistant Secretary.
- (g) Honorary Officers or members elected under Rule 4.
- (h) Two delegates appointed by each of the affiliated clubs.

Affiliated clubs shall notify the Honorary Secretary of the Association, in writing, of the names and addresses of the delegates appointed to represent their respective clubs on the Council of the Association.

Delegates will hold office for twelve months from the date of appointment by the club.

A substitute may be sent by the club provided he stands and makes himself known to the President or Chairman.

Council meetings shall be held when deemed necessary, shall be held not less than twice annually and seven days' notice with agenda, when possible, shall be given.

At any Council meeting thirteen members shall form a quorum.

All those empowered to attend a Council meeting may vote at than meeting but the Chairman shall have a casting vote only.

Any member may call for a vote by ballot, in which case voting shall be by ballot, otherwise it shall be by show of hands.

8. RULES AND ORDERS MADE BY COUNCIL.

The Council shall make separate bye-laws, rules and regulations for the conduct of leagues, competitions and matches which may be held under the auspices of the Association and may appoint Sub Committees to carry out such bye-laws, rules and regulations.

The Council or its Sub-Committees may impose penalties, financial or otherwise, on clubs or individuals for failure to comply with bye laws, rules or regulations.

Sub Committees so appointed shall have the power to give rulings in all disputes, subject to appeal to the Appeals Committee and then the Council if the aggrieved party gives notice of appeal to the Honorary Competitions Secretary within 48 hours of the ruling of the Sub Committee being notified.

The decision of the Council in all matters shall be final and binding.

All appeals shall be heard by an Appeals Committee consisting of one member of each affiliated club.

Appeals shall be subject to a payment of a fee, to be decided annually by the Council.

The quorum at any Appeals Committee meeting shall be seven persons.

The President or his deputy must attend the meetings but shall have a casting vote only.

Members of those clubs involved in the dispute shall declare an interest and shall withdraw from the meeting prior to any vote being taken.

9. SELECTION COMMITTEE.

All Island teams shall be chosen by a Selection Committee appointed by the Council and consisting of one member of each affiliated club recommended by that club.

The President or his deputy must attend the meetings but shall have a casting vote only. Provided always that a separate Selection Committee shall be elected annually by the Council, consisting of not more than five persons, to nominate and select individuals to represent the Island in the appropriate shooting disciplines at the Commonwealth Games and the Commonwealth Shooting Federation (European Division) Championships.

10. DISPUTES BETWEEN AFFILIATED CLUBS AND MEMBERS.

In any matter of dispute between affiliated clubs and between members of affiliated clubs the decision of the Council of the Association shall be final.

11. POWER OF COUNCIL.

The Council shall be empowered to act on any matter not therein provided for in its rules and regulations.

11A. DISSOLUTION.

In the event of the dissolution of the Association (which shall be passed at an extraordinary General Meeting of the Association by a two thirds majority) then the proceeds of the assets upon realisation after payment of all debts and liabilities shall be given or transferred either to some other institution or Association having objects similar to this Association or divided equally among those bodies affiliated to the Association at that time.

12. ADDITION, AMENDMENT OR ALTERATION TO CONSTITUTION.

No addition to, amendment of or alteration to the Constitution shall be made except by Special Resolution passed at a General Meeting of the Association, prior notice of the proposal having been given in writing to the Honorary Secretary of the Association and the Honorary Secretary shall give two months to all affiliated clubs.
